On the general question of allocation,
 the Gov. told us in 8329 that certain heads
 of expenditure could not be divided, & that
 the G.O.C. (who has held this view all along)
 concurred. In our reply of 23 Feb (to which
 we are awaiting an answer) we asked
 who was paying them in double charge
 & how & when it was proposed to
 divide them. The Treasury have their
 telegrams. I think they are right in
 demanding a provisional basis of division.
 I submit that that is for course.

I have laid before the Lords Commissioners of His Majesty's Treasury Mr. Read's letter of the 23rd ultimo and its enclosures further relative to the financial position of the East Africa Protectorate.

In reply I am to request you to inform Mr. Secretary Harcourt that before they can ask the War Office to make a further repayment of £30,000 to the Crown Agents on behalf of the Protectorate, they must ask for an assurance that a sum of £30,000 (in excess of the £120,000 actually repaid) has already in fact been advanced by the Protectorate for the Indian troops alone. The Protectorate Government must clearly understand that no further advance from Protectorate funds are to be made for Indian troops and that no repayments can be made from War Office funds for military expenditure on troops other than the Indian forces.

Pending more accurate allocation, a provisional allocation of common charges, such as transport, must be made on an estimated basis in such a way as to avoid payments by the War Office for non-Indian services. This allocation is essential in order to prevent difficulties in adjusting charges between the Imperial and Indian Governments.
