With reference to your letter of the 23rd April last (15/India Office/3550) (F.L.) relating to the incidence of charges for military expenditure in East Africa, I am directed by the Lords Commissioners of His Majesty's Treasury to transmit to you herewith for the information of the Army Council a copy of a further letter dated the 3rd instant and its enclosure which They have received from the Colonial Office on the subject.

In view of the further information now furnished by the Colonial Office, My Lords think that the cost of the additional 600 King's African Rifles must be accepted as a final charge against War Office funds.

It will be understood that <sup>the</sup> arrangement respecting custom charges only relates to the provision of funds in the first instance and is without prejudice to the ultimate incidence of such charges or a portion of them.
