I have the honour to forward the attached
correspondence for your information.

The chaotic state of accounts reported by the
Auditor naturally resulted by calling on inexperienced
junior officers to suddenly organise a military department
requiring some knowledge of Military Administration, and
accounts.

In view of the above, I consider the only thing
that can be done is to accept the course proposed by the
Auditor, namely, to disorganise all Ordnance accounts in
toto, up to such time as the Indian Ordnance Department
took over the Protectorate Ordnance Department and the or-
ganisation of the Military Services in British East Africa
were placed on a sounder footing by Major General R.
Wapshare with trained officers to assist him.



Sir,

I have the honour to report that considerable difficulty is being experienced by the Auditor in adjusting the accounts of the Ordnance Department during the period immediately subsequent to the commencement of hostilities.

2. You will readily understand that at that time the Protectorate Ordnance Officers, few in numbers as they were and confronted with a quite unprecedented situation, were unable to record with accuracy the multifarious transactions in which they were then engaged.

3. The matter has been discussed with the Auditor and the Military authorities and the General Officer Commanding has

10.6.15, and more fully explained in his

understand that the effect of the course proposed
would be to throw the expenditure involved on
his own expenses account.
