As it is, she has now ~~been~~ entered into a fresh agreement and we shall have to cancel it and pay her a month's salary (Clause 10 (1) of Schedule to agreement).

D. Small's letter makes it clear that she is unsuitable, and we had better write to C.A. at once & tell

With reference to my despatch No. 453 of July 22nd in which I asked that the Crown Agents might be instructed to enter into a fresh agreement with Miss M.A. Thomlinson of the Medical Department of this Protectorate I have the honour to inform you that the Principal Medical Officer has now requested that his recommendation to that effect may be cancelled owing to a report he has received from the Medical Officer of Health, Mombasa, a copy of which I enclose for your information.

2. Under the circumstances I should be glad if another trained nurse, with a sanitary training if possible, could be engaged in place of Miss Thomlinson.

re: Nursing Sister attached to  
Health Office.

I have the honour to state my opinion that it is undesirable that the appointment of Miss Thomlinson to the above quoted post should be renewed.

My reasons for my opinion are as follows:-

(1) Miss Thomlinson after a prolonged tour of duty in this country and considerable previous tropical experience did not display any aptitude for studying the habits and customs of the natives among whom her duties lay.

(2) She appeared unpossessed of the physical energy necessary to make a success of her very trying and novel duties in the tour.

(3) She had failed to become sufficiently conversant even with colloquial Kiswahili to be able to obtain an accurate knowledge of the habit of mind of the natives and so to be able to acquaint them with the objects of this office and to gain their confidence.

2. I have the honour to invite your attention to a letter written by me at the time when this appointment was mooted. Since that letter was written a number of women have been trained as sanitary inspectors and I am of opinion that from among these a candidate could be chosen more likely to fulfil the requirements than from among trained nurses.
