

## I. THE DETAILS.

(i) In his report for October Mr. T. D. Butler states that it is reported that on or about the 10th of October a large Garreh raiding party supported by some 90 Tigre left for an attack on the Degodis at Handedu on the lower reaches of the Dawa river. The Degodia being forewarned crossed the river into Oba (in Abyssinia) and safety while the Marehan Rer Ahmed Weid who were in the vicinity also fled south. The Garreh raiding party are reported to have passed on and looted the Gessara Guda, Sheigal, Gubr Wein and Shera Moge, small agricultural sections who live between Dolo and Lugh, but apparently killing no one. Mr. Butler hardly credits this report.

(ii) Mr. Butler also hears that an Aulihan Rer Afgab headman, Fitaurari Daghani, of Bei, in Abyssinia, went to Addis Ababa in September in order to attempt to arrange with the Abyssinian Authorities that the Serenli Aulihan should be allowed to join their compatriots in Bei.

(iii) In a letter dated Moyale November 1st Mr. Butler reports that Hassan Hadji Sheigal, and his two companions, who were sent by him to observe the situation in the Aulihan country, have returned. They state that there has been a certain amount of discussion between the various sections of the tribe, chiefly with regard to the division of the loot taken from Serenli and the proposed move to Abyssinia. The Rer Afgab were opposed to this plan and were successful in their resistance. Abdurrahman Kurssal however has since collected the whole tribe into a small area and has overborne all objections except in the case of the Rer Ali and Rer Afwa, both of which sections

state that they had no part in the attack on Serenli and derived no profit from it.

(iv) In a letter dated Wajheir, November 22nd Mr. Llewellyn reports that he has in gaol a Bartiri suspected of murdering one of two askaris who were carrying letters between Serenli and Alexandra when the sack took place.

(v) The Marahan have been joined by large numbers of Galti (strangers) from the other side of the river.

(vi) The Uaso Nyiro Aulihan have been rather restless. All the Tur Adi Aulihan have now returned to the river and are said to have large numbers of stock raided from the Samburu in December 1915.

## II. DISPOSITION OF OFFICERS.

Mr. Glenday with 35 Northern Frontier District Constabulary and Lieutenant N. Mortimer with 25 King's African Rifles have returned to the Garreh country.

Mr. Kittermaster has left for Wajheir.

## III. DISPOSITION OF SOMALI TRIBES.

A telegram from the Provincial Commissioner, Kiimayu, dated December 11th, states that the Italian Resident, Bardera, reports Abdurrahman Mursaal and the Aulihan to be at Serenli.
