With reference to your letter of the 4th instant
No. 59263/1915, relative to the complaint of the
French Consul at Zanzibar, respecting restrictions
placed upon the export of certain articles in
alleged contravention of treaty rights, I am directed
by Secretary Sir E. Gray to suggest for consideration
that the Colonial authorities should merely inform
the French Consul that they regret their inability
to modify the restrictions. It might be pointed out
to the French Consul that the French authorities have
taken exactly similar action in Morocco and have
prohibited the export of certain commodities except
to France.
