Encloses copy letter from two unofficial members of League Council asking that two members of that body be apptd to Executive Council. Council in minute passed by Exec. Council that there should be specific representation on that body but nominees must attend regularly. Recommends request be favourably entertained.

Mr. Grindle.

The Secretary of State is committed to the grant of elective representation of the various members of the Legislative Council. We are at present awaiting a report from the Governor on the qualifications of electors, electoral areas, and the manners in which the Indian, Arab, and native communities best be represented. The present (nominated) unofficial members have raised the question of the appointment of unofficial members on the Executive Council, expressly in connection with the expected report on electoral questions. I would take them at their word, and give them a reply as to unofficial (nominated) representation on the Executive Council, when we reply on the electoral question. It will be easier, when we have considered the questions that arise out of the settlement of the details of elective

STATEMENT OF OBJECTS AND REASONS.

-----

The "Anzac" (Restriction on Trade Use of Word) Ordinance, 1917, has been enacted for the purpose of preserving the word "Anzac", which is indissolubly associated with the gallant deeds of the Australian and New Zealand Army Corps at Gallipoli, from falling into disrepute.

2. The Bill follows the provisions of the "Anzac" (Restriction on Trade Use of Word) Act, 1916, of the Imperial Parliament and can in my opinion be enacted forthwith.

3. A comparative table is annexed hereto.
