He provision is made for payment of rent in advance, and, on the ordinary legal construction therefore rent is payable on the expiration of the half-year and not on the commencement.

- 2 Your statement that the rent has invariably been paid in advance must have been made under a misapprehension of the facts. The rent for the half-years ended June 1912 and December 1912 was paid 4th March, 1913. That for the next half-year was paid 24th June 1913, and the next 21st July 1913. The last rent paid was some menths in advance of the due date.
- Application has been made to the Crown Agents to remit the rent for the present, the War having made prefitable farming operations impossible.
