In continuance of letter No. 4200, dated 15th July 1917, from the Field Disbursing Officer, "E.A.E. FORCE", Daresalam, to your address, forwarding copies of your letter No. P. 2040, dated 10th May 1917, and its enclosure to this office for disposal, I have the honour to explain as follows:-

Captain (now Major) Jesser Coops of the 2nd Rhodesian Regiment received two sums of £200, and £400/- from the Field Disbursing Officer, Indian Expeditionary Force 'B' on the 3rd July and 1st September 1915 respectively. In support of these advances the officer rendered a Cash Account for £374. 17. 3 (copy enclosed), leaving a balance of £229. 2. 9 which was refunded by the Pay Master E.A.P.C. to the Field Disbursing Officer in Cash and credited by the latter to the War Office in his account for January 1916.

Of the total sum of £374. 17. 3 accounted for by Major Jesser-Coops, a sum of £274. 8. 11½ was refunded by the Pay Master, E.A.P.C., and credited to the War Office by the Field Disbursing Officer in his account for October 1916. The balance of £100. 8. 3½ should, it is presumed, be treated as a final charge against the War Office.

I am directed to transmit, herewith, a copy of correspondence regarding the adjustment of advances made by the Field Disbursing Officer, Indian Expeditionary Force "B" to Captain Jeever Coope, 2nd Rhodesian Regiment.

It will be noticed that the Paymaster, East African Bay Corps, has secured the adjustment of the advances in question with the exception of a balance of £100. 8. 3d, and I am to request that he may be called upon to refund the amount in question to the Field Disbursing Officer and effect the necessary adjustment in his account or, if the amount is not properly so adjustable, that a report on the subject may be furnished, together with a detailed statement of the various transactions making up the amount.
