

example, the arrangements made at the outbreak of hostilities provided for no emoluments to officers or men invalided out of E.A. and it was subsequently arranged (early in 1915) that in such cases British rates of pay, without allowances, should be granted as from the date of leaving E.A. to the date of return. Similarly no provision was made for the grant of compensation to dependents of officers and men killed in action or to men disabled on active service, and arrangements were subsequently made for the adoption of British Army Regulations in all such cases. It cannot therefore be maintained that the fixing of consolidated rates for the local E.A. forces on the outbreak of war excluded the possibility of their being granted a gratuity on discharge such as is now proposed. Having regard to the fact, to which attention has already been drawn, that the consolidated rates of pay drawn by these local forces are not far different to the pay and allowances drawn by the British Army, Mr. Long thinks that there is a very strong case for granting a gratuity in these cases and he hopes that the Army Council will be able to reconsider their decision in the light of the above considerations.

It would appear that the Army Council are under a misapprehension in thinking that it is proposed to assess the grant for officers on the consolidated pay. Mr. Long thinks that it is clear that the Governor's intention is to grant an officer precisely the same amount of gratuity as he would have received if he had been an officer of the British Army. This would be analogous to the arrangements made for the grant of disability compensation in the case of officers of the E.A. forces.

In the case of the Lieut.
