Enclosure to 4604 marked X state that
Major Grogan arrived on the 6th of May
His examination in this country was
therefore up on the 6th of November
but he spent a good deal of time
on the E.A. L.S. Selection Board;

Mr Jeffries tells me that he put in
17 half-days on Selection Board;
& attended every day & all day from
the 5th to the 16th of September -

His whole duties in the connection with the
L.S. scheme extended over a period
from the 27th of June to the 16th of
Sept. and involved him in a great
deal of correspondence, & Mr. Jeffries
agrees with me in thinking that he
might well be granted ^{an extension} of two months
to the time in which he can avail
himself of a passage.

I authorize the C.A. to extend
the period of his eligibility for
passage for 2 months on account
of his work in connection with the
L.S. scheme, & would be asking
him to give reasons for a further
extension should he require it.
