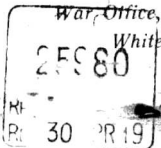

Dear Mr Mächtig,

Your letter of the 17th instant is to hand.

As regards gratuities to native officers of the Indian Army, such officers are not eligible for gratuities under Article 497 of the Pay Warrant. Terminal gratuities on the following scales have, however, been arranged:-
