Sir,

In reply to your letter 59541/1918 of the 21st ultimo relating to the case of Temporary Captain A.A.C. Jeffrey, I am directed to state that the evidence accompanying your letter is not sufficiently explicit to enable the Minister of Pensions to advise with certainty as to the grants which might be made in such a case under the regulations of this Department, but in making the Secretary of State would be justified in dealing with it in the following lines:

The disease which caused Captain Jeffrey's invaliding was aggravated by military service in the present war and it appears probable that he was actually disabled between July 1917 and the date of his death. Retired pay at the rate of £175 should therefore be payable for this period.

If expenses were incurred in respect of his maintenance and treatment in the Mental Hospital, Pinner, Middlesex, fees would be payable from public funds to an amount not exceeding £4 a week, but this sum would be deducted from the maximum retired pay in respect of the cost of maintenance.
