I spoke to you about the ^{staff} arrangements necessary in connection with the cessation of the band settlement work.

Messrs. Wood, Bigg & Cooper return to the C.O. Mr. Baker and Miss Hasting have left. Mr. [unclear] (boy messenger) and the chairwoman will be taken over by the Office-keeper.

There remains the question of our messenger, W. J. Smith. He wishes to be employed at the C.O. and I understand that the Office-keeper is willing to take him on, but not till Oct. 1st. It is desirable in his interests that his service should be unbroken and he must therefore be placed on leave until the end of the month. The full pay leave due and exact of his service for the beginning of May is 4 days, taking him up to the 23rd of Sept. You thought that the remainder of the time, till the C.O. take him over might be on full pay from E.A.P. funds.
