DEPUTY SUPERINTENDENT,

WHEREAS Hans Jørgen Pichman or Pechmann
Amley White late of St. Petersburg in the Russian
Empire accused of the commission of the crimes of criminal
misappropriation and theft within the jurisdiction of
the Russian Empire was delivered into the custody of
the Deputy Superintendent of the Embass Jail by
warrant dated the twenty-eighth day of July 1918 pursuant
to the Executive Order of the 1st August 1908.

I, Henry Conway Selfield, Knight
Baronet of the Most Distinguished Order of Saint
Michael and Saint George, Governor and Commander-in-
Chief of the East Africa Protectorate, do hereby, in
pursuance of the said reference, order you, the
said Deputy Superintendent, to deliver the body of
the said Hans Jørgen Pichman or Pechmann alias
Amley White into the custody of the said Frederick
Roberts,

Roberts, AND I command you the said Frederick
 Roberts to receive the said Hans Jorgen Dickman or
 Dickman into your custody and convey him within
 the jurisdiction of the said Russian Empire and there
 place him in the custody of any ^{person} or persons appointed
 by the said Russian Empire to receive him for which
 this shall be your warrant.

 1890.
