The carrying on of hostilities in British East Africa resulted in the military authorities in that country requisitioning the Uganda Railway, the Water Supply, and other of the Company's properties, with the consequence that while it contemplated starting its trading at the end of 1914, such trading had to be deferred for nearly four years. Even now it can only be carried on in a restricted manner and under very great difficulties, which have been caused by the withholding from the company of such vital facilities during the most crucial period of its operations. Notwithstanding the serious setback which the Company has had to encounter during the past 4 1/2 years of war, it has utilized such period in completing important works in East Africa, with the result that it is now producing its soda and shipping it to various parts of the world in such quantities as sea transport permits. Similarly, the company has completed its works in Calcutta and is now manufacturing Caustic Soda there and has to make provision for working capital to run the works and to purchase various materials required and to provide, also, the requisite packing for the Caustic Soda.

The Uganda Branch Line Railway and Water Supply in the East Africa Protectorate, which, under the Company's Agreement with the Government Agents for the Colonies have been taken over and are being worked by the Uganda Railway Administration, have all cost considerably more money than was estimated, with the consequence that the working capital provided for in the Company's prospectus has had to be utilized for this purpose, with the result that fresh working capital is now necessary. Additionally, by reason of the incidence of the war, the Company has to face substantially higher disbursements for all materials, fuel, and freight charges.

The operations of the Company are a means of bringing considerable revenue to the East Africa Protectorate. For every ton of Soda the Company produces from Lake Magadi and despatches to Kilindini at the Coast for shipment it pays to the Uganda Railway a railway freight of 1/6d. per ton per mile, equivalent to about 16/- . Again, for every ton of Soda the Company produces from Lake Magadi, it pays to the East Africa Protectorate a royalty of 2/- . Apart from these two important payments, the Company has imported and still imports large quantities of machinery and materials into the Colony, which also create trade within the British Empire and are a source of revenue to the Protectorate, and the Company is also a large employer of native labour, again to the advantage of the Colony.

The Company desires to emphasize the extreme importance of its operations in fostering a great enterprise in the East Africa Protectorate, one that is calculated to be of paramount interest for the welfare of that British Colony.

The Colonial Office in London has always extended sympathy towards this enterprise and on previous occasions has communicated with your Department expressing the view that it is in the public interest that the Company should be permitted to raise fresh capital.

Dear Sirs,

I beg to submit to you copy of the application that has been put before the Capital Issues Department of the Treasury, with a view to the issue of £500,000. 6% First Mortgage Convertible Debentures by the Magadi Soda Company, Limited.

In accordance with clauses 50 and 52 of the "Contract for the construction, maintenance, and working of a Railway to Lake Magadi in the East Africa Protectorate as a branch of the Uganda Railway", and ^{the} clause 24 in the "Lease of Lake Magadi and other lands in the East Africa Protectorate for working of Soda and other Deposits", it is provided that no Debentures can be created without your written consent.

The application for authority to issue these Debentures has been submitted to the Colonial Office, whose support has been promised.

It is hoped, owing to the urgency of the Company's requirements, that the issue may be made at an early date. It would, therefore, be appreciated if, with the particulars of the application to the Treasury before you, you could see your way to signify your assent now to the creation of the Mortgage as soon as the Treasury has agreed to the issue. If your assent is given, steps could be taken immediately to draw up the necessary documents.

The Crown Agents for the Colonies.

I should like to point out to you that the period of the proposed Debentures is only 15 years and that an option is given to the Debenture Holders, during a period within the life of the Debentures, to convert the latter into Ordinary shares of the Company.

The Capital of the Company will be increased by a ³⁰⁷ sufficient number of Ordinary shares to meet the rights of conversion of the Debenture Holders, but these shares will not be offered for subscription and will be held in reserve subject to the rights of the Debenture Holders to convert.

It is anticipated by the Directors that the Debenture Holders will exercise their rights to convert their holding into ordinary shares within the period laid down.

It is further pointed out that in the event of the Debenture Holders exercising their right to purchase the Railway from the Company during the life of the Debentures, the purchase price will be more than sufficient to provide for the redemption of the Debentures.

Report and Balance Sheet

For the Year ended 31st December, 1917.

REPORT OF THE DIRECTORS

to be submitted to the Shareholders at the Seventh Annual General Meeting of the Company to be held at Winchester House, 20 Old Broad Street, London, E.C. 2, on Monday, the 24th June, 1918.

The Directors beg to present the Balance Sheet and Profit and Loss Account for the year 1917, duly certified by the Auditors, shewing a debit balance of £16,771 5s. 6d.

The volume of trading during the period covered by the accounts shews some expansion, but was again on a very restricted scale; consequently the Directors have not been able to make any allowance for depreciation. The Company has, however, rendered its claim for compensation for the use of its railway and water supply by the Military Authorities in British East Africa. When this claim is paid the Directors will be in a position to make an allocation for depreciation.

During the year under review the Company continued to experience serious difficulties in regard to developing its trade, and it was not until towards the close of 1917 that the restrictions on the utilisation of Native labour were sufficiently removed to allow of the production and constructional work being proceeded with.

The Directors announce, with regret, the resignation of Sir Lionel Phillips Bart. from the Board owing to pressure of Government work. On their invitation Mr George Pauling has joined the Board, and now offers himself for re-election.

Lieut. Colonel S. H. Pollen, C.M.G., Captain W. H. Seton, M.C., and Mr Samuel Samuel, M.P., retire, but, being eligible, offer themselves for re-election.

The Auditors, Messrs. Turquand, Youngs & Co. also retire, but, being eligible, offer themselves for re-election.
