Sir,

In further continuation of my letter of February 6th, I beg to state that the paper from the Governor of East Africa Protectorates was duly considered by Mr. Justice Peterson's Sub-Committee. I am directed to ask if it is possible for the Colonial Office to obtain the names or indicate the identity of offenders referred to in the document in question. Two German Europeans appear to have been concerned in these offences and it is desirable that they should be identified. Presumably they have not returned to Europe. Without evidence of the type indicated it will not be possible for my Committee to take any steps that can lead to the punishment of the offenders.

I am also directed to ask for any other information that the Colonial Office may possess as to war crimes in any of the German African colonies. I have General Northey's Report on certain outrages committed by Germans on two British soldiers belonging to forces operating in German East Africa, this Report is dated March 27th, 1917.

Sir,

I have the honour to acknowledge receipt of your
letter, No. *60* 2180/1919, of the 15th February.

I am directed to write to thank you for having
given your expert to the application of this Company to
the Treasury for permission to issue £200,000 of First
Convertible Debentures; further for your advice
that the ~~the~~ ~~Uganda~~ ~~AGENTS~~ for the Colonies have been authorised
to consent to the creation of the Mortgage on the Magadi
Branch Line Railway and the Company's other properties in
East Africa.

On the other hand the Board of Directors of this
Company ~~has~~ ~~been~~ ~~informed~~ your statement that the Uganda
Railway Company will be unable to deal with any large in-
crease of traffic from Lake Magadi to the Coast for some
time yet.

I have to point out in this direction that the
truck accommodation which has been placed at the Company's
disposal up till now will by no means be sufficient for
commitments which the Company has made for the future, or
for dealing with the quantity of Soda which can be produced
from and handled at the Lake, and which is required in sub-
stantial quantities in order to give a return to the Company's
Shareholders on their holdings.

In this connection I am directed to advise you that at the present moment the Company is on the point of closing a contract with important buyers of Soda which will necessitate deliveries to them of approximately 100,000 tons of our commodity per annum. You will thus understand that for this particular business alone we should require trucks for 2,000 tons per week, whereas we have to fight hard now to get such accommodation for only half the quantity.

Further in regard to this matter, I beg to refer you to a letter addressed to you from this Company on the 25th February, 1913, covering a letter to the General Manager of the Uganda Railway Company, dated the 19th February, 1913, in which formal notice was given that trucks for 80,000 tons of Soda per annum would be required, such notice being given in accordance with Clause 43a of the Agreement for the construction of the Magadi Railway.

Again, on the 8th October, 1918, acting on instructions from the Head Office in London, our General Manager in British East Africa gave twelve months' notice to the General Manager of the Uganda Railway, Nairobi, under the same clause of the Agreement, that the Company requires the Uganda Railway Administration to carry 100,000 tons per annum of our Soda from Lake Magadi to Kilindini.

I have recapitulated the above mentioned two formal letters in order to convey to you that this Company has always recognised well ahead its commitments in the future, and has acted in accordance with the terms of Agreements between the Crown Agents for the Colonies and itself.

The Board of Directors of this Company feel that the Colonial Office should recognise that the Magadi Soda Company is now a going concern and the Railway and Works, on which a

very large sum of money has been spent, and are now ready to produce, treat, and export the Company's product; consequently the remaining facilities required in order to ship it should not now be withheld.

The facilities I have outlined above are those to which the Company is fully entitled under its Agreement with the Crown Agents for the Colonies and it is now ready and anxious to earn a revenue for its Shareholders. It would be unfortunate if the only obstacle to this should be the failure of His Majesty's Government to fulfil its obligations.
