We the undersigned beg to request you on behalf of the
Austrian & Hungarian combatant and non-combatant prisoners of
war to support us in our endeavour to be released from intern-
ment as speedily as possible.

Considering the fact that the fifth hot season is
approaching and that many of us have been in the tropics
several years before the outbreak of war we hope you will
regard our request reasonable and we shall thank you very
much for your telegraphing on our behalf to the Governments
of Austria and Hungary to take all steps necessary to arrange
for our liberation before the hot season. We further beg to
ask you to approach the British and the British Indian
Governments in this matter.

We beg to mention that the vast majority of us wish to
be repatriated but there are a few men who are anxious to
return to their previous places of residence in India, Africa,
etc. and we shall feel obliged for your taking such cases
under consideration. Individual applications have been and will

be out in such cases.
