

Dear Sir,

I am directed by the East African Section of this Chamber to say that at a meeting held yesterday it was reported that Colonel the Hon. A. C. Macdonald, late Director of Agriculture of British East Africa, had made a proposal for a Government loan, not to exceed £4,000 to be placed at the disposal of the British East Africa Department of Agriculture to be used in the purchase of pedigree bulls and rams, probably best from South Africa, for importation under Government auspices into British East Africa and there to be sold to the farmers.

The Section instruct me to say that they desire to cordially endorse this proposal and to recommend it to the Secretary of State for his early and most favourable consideration.

I am to point out that the proposal appears to be on all fours with the importation of flax seed by the British East Africa Government last year and is not, therefore, entirely without precedent.
