local Banks' doing business in East Africa, and vice versa.

Our feeling at the time of writing this is that the circulation of the local Rupee of a different standard to that of the Indian currency, would, for some time, complicate matters, and in any case would create an unfavourable rate of Exchange in East Africa in its relation with other countries. May we suggest for your kind consideration whether it would not be advisable for the present currency to continue, pending the introduction of a sterling currency, thus doing away with any intermediate stage.
