Sir,

I have the honour to report that owing to representations made to me by the Commissioner of Police, a copy of whose affidavit is attached, I have found it necessary to report to India a clerk of the name of Tirath Ram, who has been employed in the Audit Office.

2. This man was engaged as a clerk on the Uganda Railway on 4th July 1913, but was subsequently discharged from that Department owing to the Political views held and expressed by him. He has had considerable quantities of seditious literature addressed to him regularly and the Commissioner of Police is of opinion that he has been endeavouring to excite animosity between the Indian population of this Protectorate and His Majesty.

In Dispatch No. 54 of 36/5/11

I, William Kilminster Notley, Commissioner of Police, East Africa Protectorate, make oath and say:-

1. That Ram Lal Sapru has had addressed to him c/o Tirath Ram the letters attached hereto and marked "A" and "B" respectively.
2. That Ram Lal Sapru has frequently had numerous copies of a seditious publication entitled the "Ghadar" addressed to him.
3. That Tirath Ram has frequently had copies of the aforesaid publication addressed to him.
4. That this deponent believes that both the aforesaid Ram Lal Sapru and the aforesaid Tirath Ram are intriguing against His Majesty's power and authority in East Africa and are endeavouring to excite enmity between the Indian population of East Africa and His Majesty.
5. That in view of the presence of large numbers of Indian troops in the Protectorate this deponent believes that the continued presence of the aforesaid Ram Lal Sapru and the aforesaid Tirath Ram in the Protectorate is a menace to peace and good order in East Africa.

Dear Countrymen,


