Approves rules for Uganda. Presumes acceptance for Uganda will not be embarrassing in discussing application to Nysid and Somaliland.

Until we receive replies from Nyasaland and Somaliland to our despatch of 26/7/14 we had better not do more than inform Uganda and P.A.P. that the rules are approved subject to any criticisms which the Govts of Nyasaland and Somaliland, who have been consulted, may have to offer.

①: Ackn. recd. of Gov/3604/16. Approves the rules subject to the condition mentioned above and reminds Govt that we have not yet had ^{reply} reply to our despatch of 21 March '14 (10682) asking him to consult the Govt of India on the pension question.

②: Approves the rules for Uganda on the same condition.

③: Ackn. recd. of this letter and says that the Sgt proposes to ~~approve~~ inform the Govts of P.A.P. and U.G. that the rules are approved subject to any criticisms which Nyasaland or Somaliland may have to offer.

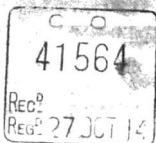

I have laid before the Lords Commissioners of His Majesty's Treasury Mr. Read's letter of the 7th instant (36076/1914) and its accompanying copy of a despatch from the Governor of the East Africa Protectorate and its enclosed copy of rules drawn up for the employment of Assistant Surgeons of the Indian Subordinate Medical Department in the East African Protectorates.

They presume that Mr. Harcourt is satisfied that acceptance of the rules for Uganda will not be embarrassing in discussing their application to Nyasaland and Somaliland.
