Protectorates in the present financial year.

2. As Their Lordships are aware, it was decided that, even if the Loans Bill could not be passed this year, a sum of £210,000 should be provided for the purposes of the loan services in the year 1914-15.

3. On this understanding, certain expenditure has been incurred, on the liability for it assumed, which makes it necessary for Mr. Harcourt to ask Their Lordships to agree to the issue of some part of the £210,000 before the end of the present financial year. The Loans Bill has been passed, and, in normal circumstances, there would presumably have been no difficulty in obtaining the full amount expected to be required; but,

apart

apart from the importance of restricting loans, for purposes other than the war, within narrow limits, there could now be no question of so large a sum as £210,000 being required in the present financial year.

4. In connexion with the Nyasaland Estimates for the current year, Their Lordships agreed to the proposal to charge to the Loan certain items for road construction amounting in all to £9,815, omitted from those Estimates. According to Mr. Harcourt's latest information, the expenditure on these services during the current year may be expected to amount to £7,000 only, and he would propose to meet this charge from an advance under the Act.

These figures do not include freight or cost of completion in the Protectorate, which may be taken to increase the cost by at least 30%.

In addition to the above services, Mr. Harcourt regrets to find that, by the action of the General Manager of the Uganda Railway, the Government of the East Africa Protectorate has been committed to the immediate purchase of a brickfield and works at Mombasa at a price ~~of which~~ *may amount to £7,500,* about ~~£6,200,~~ exclusive of the valuation price of the stock. The principal item in the loan programme for Nyasaland is the extension northward to Lake Nyasa of the existing railway, and engineers, now employed in connexion with the extension southward to the Zambesi, will be available, about January next, for the survey of the northward route, and their employment on this work would dispense with the necessity for sending out a special party from this country. The cost cannot be estimated accurately, but would not be likely to exceed 25,000.

// The full amount involved will, however, not be required for some time as the Crown Agents for the Colonies have, at Mr. Harcourt's request, made arrangements for delivery to be postponed until June 1915 of all the rolling stock in question except the three engines, which were paid for in August and have no doubt already arrived in East Africa. If, therefore, an advance under the Act is possible in the summer of 1915, there will be no need to make earlier provision for these items.

12. In the circumstances, it may be assumed that the amount immediately

14. Mr. Harcourt will be glad to be furnished with Their Lordships' general views at an early date, as the question of the Nyasaland railway survey should be decided as soon as possible. But the delay which has occurred in settling the terms of the local Loan Ordinances makes it impossible for the issue of an advance to be made at once, and there will be an opportunity for consulting the Governors before the exact amount ^{required} need ~~be~~ ^{to meet existing commitments need} be determined.

15. As regards the year 1915-16, the advance amount of the advances which will be required there must depend on the arrangements which T.C. are prepared to propose for 1914-15, but, generally, Mr. Harcourt proposes that ^{the amount} ~~the~~ ^{to be reported to the local loan committee} shall be ~~reduced~~ ^{reduced} until the financial position is clearer.
