Reference to my telegram 10th  
September 1915 to provide for registration of our  
population prepared on lines similar to those of  
the Imperial Act? has been passed by Legislative  
Council today and I propose to assent to it.  
Pending receipt of registration returns I am appoint-  
ing a Mixed Committee to consider steps to be taken  
to utilize our population to the utmost for military  
purposes and to place all classes on war footing  
with possible unimportant exceptions whole community  
demands this action. General Officer Commanding and  
I are anxious to <sup>and</sup> do as much as possible.

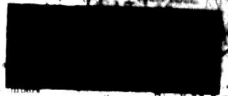
