I have the honour to acknowledge the receipt of your despatch No. 476 of the 30th of June relating to the loss incurred owing to the embezzlement of Government money by Postman Fazal Mohamed Shah last year.

2. After further consideration of the matter with my Executive Council in the light of your remarks, I have approved the infliction of a fine of Rs. 25 on Mr. Douglas and Mr. Hayter as a penalty for careless omission of duty and not as an endeavour to recover any portion of the amount lost. I did not consider that such action could with propriety be taken in the case of Mr. Lettis and Mr. Youll.
