Enclosing Secretary of State's No.426 of 9/6/1915MEMORANDUM.

In order to meet the opinions expressed by the Advisory medical and Sanitary Committee for Tropical Africa, the following alterations and additions to the proposed plans are suggested:-

1. Expansion of Sisters' dining & sitting room.

To remove the partition wall shown as existing between the Sisters' dining and sitting room, and the Medical Officer's room.

By so doing an additional space will be provided of 17' x 10' 6" inclusive of wall space; this will materially add to the comfort of the occupants. I propose that the intervening wall be removed, and not a doorway knocked through it.

2. Medical Officer's room

This to be placed where the Microscopic Room and Dispensary is now shown. If this conversion takes place attention should be paid to the lighting

and ventilation of the room.

3. Mortuary & Laundry.

The site for the Laundry is shown on the block plan, probably this may have been overlooked by the Committee.

This building should contain-

- a. Drying room
- b. Ironing room
- c. Washing room, boiler house
- d. Sorting room.

a. Drying room. to have radiators provided, and hanging lathes worked by pullies. This room is an essential as proximity to the sea and the two monsoon seasons maintain the saturation point for a long period.

b. Ironing room. Electric irons should be used.

c. Washing room. Should be provided with mechanical washers and ringers, and attached to the boiler house means should be provided for disinfecting clothing and apparatus.

d. Sorting room, to be provided with shelves and cupboards.

The entire building to be lighted with electric light, and its drainage carried down and connected with the main drainage between the Hospital and administration block.

All rooms in this building should be provided with louver windows and be rendered mosquito proof. Floors, walls and ceilings to be of impervious material.

4. Mortuary.

Provision should be made for

a. Receiving room with tressels for 3 coffins.

b. Post Mortem room, drained to centre gully, trapped, provided with 2 slats slabs guttered and drained, sinks and sloping slabs for examination of organs, and shelves for specimens, and disinfectants. Water to be laid on to all parts.

c. Medical Officer's room provided with furniture and lavatory accommodation.

5. Dispensary.

I propose that this be placed in the position of the kiosk now described as the admission officer's room situated in the fore court.
