RESUME OF WAR DIARY OF GENERAL STAFF, I.B.F.

November 6th-12th, 1915

November 6th. In the North of Portuguese East Africa the majority of the inhabitants, and especially the business men, are pro-German. Stores are run into German East Africa both by land and sea.

The Portuguese Expeditionary Force is anti-German, but inefficiency, due to sickness and other causes, has rendered it impotent.

Enemy agents are resuming activity in the neighbourhood of Kasigau and Pika Pika.

It is confirmed that there are only 8 companies in the Taveta district; no guns at Mbuyuni or Taveta

A mine containing 30 pounds of dynamite was removed from mile 17 Voi-Taveta Railway.

From Uganda the enemy are still reported to be moving troops towards the Belgian Frontier in anticipation of a Belgian offensive

The latest estimate of the snemy forces is ;

Buropeans 2,132
Askaris 9,430
Leviss and Recruits 2,280
Guns 75
Machine guns 75

Among the guns are included for 4.1 and 6 moder field guns of unknown call three

November 7th. The Admiral asked if it would be advisable to apply to England for some scaplanes to assist in possible future operations against Daressalaam or Tanga. The General Officer Commanding replied that

he considered that it would be advisable to have them in the event of their being required.

November 8th. Additional railway track, complete, and 15
loco. engines have been asked for tron India by the
Director of Railways in B.E.A.

One section of 27th mountain battery is proceeding to Uganda to assist in threatening the Kagera line with the object of making a diversion in favour of the Belgians.

November 9th. In order to co-operate with the Belgian advance on Ruanda, a strong demonstration will be carried out from the Ragera line in conjunction with a naval threat on Bukoba.

An unreliable report states that the Germans have given the Portuguese an ultimatum, which expires in about 15 days, as the Portuguese are prohibiting the passage of mail matter from German East Africa.

The small rains' have set in well, and there is premise of a good fall.

The enemy are reported to have avrongly reinforced the Kivu-Russisi line in Ruanda. This may be a prelude to a second attempt on Luvungu.

The War Office have offered a Battery of 4" guns, for serwide in British East Africa, through South Africa. In reply to this it was pointed out that Howitzers would be much more useful and would be preferred. It was suggested that India was prepared to supply these Howitzers, if the personnel which was offered with the guns could be diverted to the latter.

The Union Government have offered an additional mounted

mounted regiment to be affiliated with the Infantry Brigade, and that offer has been gladly accepted. The proposal will therefore be put up to the War Office in aus course.

November 10th. The 40th Pathans are to be sent here instead of the 28th Infantry.

Heavy rain has fallen, fairly generally. This will have filled the waterholes, thus making the raiding of the Uganda Railway an easier task for the enemy.

November 11th. The Telegraph Service in British East Africa and Uganda has offered to find a Section to take over the complete working and maintenance of the Military Field Telegraph lines in Uganda so as to free the regular military telegraphists for the active lines of advance. This offer has been abbepted.

Definite information has been received from South Africa that the Union Government has decided to send a complete mounted brigade of four regiments as well as the additional mounted regiment referred to in the Résume for the 9th.

Uganda Railway shall be temporarily vested in the Director of Railways, Sir William Johns, and definite arrangements have been made to this effect.

Marjoreni is now reported to be clear of the enemy.

One enemy company at least is still using black powder

powder rifles

The enemy patrol, which had been reported as being North of the Mara River, is now reported to be working South.

RESUME WAR DIARY - GENERAL STAFF, I.E.F. 'B'

Rosember 13th.

A request has been reserved from the pelgisme that they might be permitted to attach an officer of their Starr to the Officer Commanding the Kagera Line. This was acceded to by General Tighe.

The appointment of Inspector Communications will be vested in Light. Dof. Edwards (Inspector of Police, B.E.A. and Uganda). He will be relieved of the command of the Kagera line so as to enable him to take up his new appointment early in December.

India has notified inability to supply vessels for the conveyance of the South African reinforcements to Mombasa. The Admiral is therefore arranging to requisition ships for the purpose at the Cape.

November 14th. All quiet.

November 15th. It is reported that there is now a party of 70 enemy mounted men in the Taveta district.

In the Eastern Lake Area the enemy still have several small posts North of the Mara River, but they do not appear to be contemplating the offensive.

The following distribution of the enemy strength has been received,-

Tanganyika-Kivu Line.

325 Europeans, 600 askaris, 1,000 levies, and 8 machine guns.

Kivu-Mulera Front.

76 Europeans, 800 askaris, 200 levies, and 2 guns, with 4 machine guns.

Kagera River.

- 38 Europeans, 1,000 rifles, 3 guns, and 3 machine guns.

 Bukoba and Karagwe Districts.
- 37 Europeans, 650 riffes, 1 gun, and 2 machine guns.

It is probable that the above figures are over-

In the Kigeri district the Relgians are said to have 30 Europeans, 1,030 rifles, 7 gams, and 4 materine guns.

The Naval Expedition on Lake Tanganyika is constructing a small port under the guns of Lukuga.

On the Nyassaland Border the Belgians are withdrawing their troops to the Congo.

November 16th. One hundred miles of telegraph line,
complete, are being sent to the Belgians to enable
them to link up Kibale with Butchuru.

The War Office are now sending the personnel from England for the Howitzer Battery which was promised by India many months ago in the event of such personnel being available.

November 17th. On the recommendation of the Provincial

Commissioner, Voi, it has been decided that the

Wakamba South of Mwatate shall be removed from that

Locality as they are considered untrustworthy.

The 129th Paluchis are being sent from Egypt to British East Africa in addition to the 40th bathans. This should mean a devalderable addition to our fighting strength.

A reliable source confirms the continued passage of dhows from Portuguese East Africa to Mikindani.

The report of guns being located at Dar-es-salaam is confirmed.

All is reported quiet from the Coast. Several guns are reported to be at Tanga: this requires confirmation

confirmation but is probably correct. Unconfirmed fimours of the construction of rail or tramways from Dar-es-salaam to Muhezi, and from Mombo to Tabera, continue to be reported.

Prisoners continue to confirm the fact that there are not more than 8 companies in the Taveta.

All is quiet in the Fastern Lake Area.

The morale of the enemy on the Ragera Line is reported to have been disturbed lately owing to our demonstration at Kimws.

Enemy are reported to be still requisitioning porters from Bukoba district for service at Moshi.

November 18th. Another attempt was made by the enemy to lay a bomb on the Uganda Railway at mile 160; the enemy were driven off by our patrols.

November 19th. A revised order of arrival of the South

African reinforcements, has been sent to General Smuts.

To adequately protect the railway line an advance is necessary, and to admit of an advance more infantry are essential.

India is unable to provide another Sapper and Miner unit, which is unfortunate as their services would be invaluable.

The General Officer Commanding and Staff left for Kajiado.

On the 16th instant, at 7.30 p.m., unsuccessful attempts were made to blow up the Uganda Railway at 157/15 and 158/18.

On the 18th another attempt was made at 2 a.m

at mile 160/5. Our troops drove the enemy off.

At 1.30 a.m. to-day a successful attempt was made, resulting in the densitiment of a portion of the train.

the train.

A strong hestile party made an attempt on the Vol-Martau line at mile 36 last night. The enemy had one killed and several wounded.
