With reference to your letter of 12736 of  
March 23rd last suggesting that information as to  
Mr. Gillman and other British subjects in German  
East Africa might be obtained through His Majesty's  
Consul-General at Lourenco Marques, assisted by the  
Portuguese authorities, I am directed by the Secretary  
of State for Foreign Affairs to transmit herewith,  
for the information of the Secretary of State for  
the Colonies, copy of a despatch from Mr. Errol  
MacDonell from which it will be seen that he has been  
unable to obtain the information.

In the circumstances the only remaining method  
of obtaining information would be by means of a  
telegram from the German Government to the German  
authorities in German East Africa, transmitted through  
His Majesty's Government. This proposal, which is  
mentioned

mentioned in the letter from this Department  
No. 41346 of April 12th last, has been accepted  
by His Majesty's Government, but no information  
has been received to show that the German Government  
intend to give effect to it, and a reminder has  
therefore been addressed to the United States  
Ambassador in the matter.

Sir:-

I have the honour to acknowledge the receipt of the Foreign Office despatch No. 14 (34008/15) of the 2nd. April last, transmitting despatch from the Colonial Office of the 23rd. March, relative to an enquiry as to the present whereabouts of Mr. Clement Gillman.

I regret to report that I have made such enquiries as are possible, in regard to Mr. Gillman's whereabouts, but have been unable to obtain any information on the subject, nor can the Portuguese authorities render me any assistance.

In view of the fact that the last letter received by Mr. Gillman, senior, from his son was dated July 8th. of last year, and was written from Tabora, some 500 miles from the coast, and also seeing that there is no British Consular officer in the territories of the Companhia do

Myself, it would be a matter of very considerable  
difficulty to obtain any information as to the utilization  
of the same. I have, however, had a number of  
copies of the same shipped.
