War Office, June 17, 1915.

With reference to the agreements which have been arrived at with the German Government for the mutual repatriation of various classes of enemy subjects, I am informed by the Army Council to inform you, for the information of Secretary of State, that enquiries have been received from various quarters regarding the application of these agreements to India and to the colonies. In this connection I am to draw your attention to your letter of the 26th August, War Office reply of the 27th August, and to your further letters of the 29th September addressed to the War Office and of the 10th October addressed to the Foreign Office, and to the notes to the United States Ambassador of the 31st August and 5th October, and from the United States Ambassador of the 22nd October. From these it would appear to the Council that the agreements in question only apply to such enemy subjects as might be detained in Great Britain, to the exclusion of those interned or resident in India or the colonies.

That this is also the view of the German Government would seem to be indicated by the fact that they have recently requested the extension of the exchange of unaccompanied officers and men to cover the case of severely wounded prisoners of war held now in protectorates.

I am to ask whether Sir E. Grey concurs in this interpretation of the agreements, and to point out that the acceptance of these agreements as being applicable to the respective portions of the British and German Empires is all to our disadvantage, as we are in a position to fulfil our undertaking, whereas Germany cannot do so.

Sir,

I am commanded by the Army Council to acknowledge the receipt of your letter No. 79807/10 of 24th June, regarding the repatriation of German subjects detained in India and the Colonies.

In reply to the last paragraph thereof I am to acquaint you, for the information of Secretary Sir A. Grey, that the Council would be willing to agree to arrangements being made for the mutual exchange of such of the civilians who are now detained in German East Africa and British East Africa respectively as fall within the categories which form the subject of already existing agreements between this country and Germany.

I am to add that, so far as is disclosed by the information in the possession of the Council, the number of British subjects detained in German East Africa is as follows :-

With reference to your letter of the 3rd ultimo transmitting a list of missionaries of your Society detained as prisoners of war in German East Africa, I was directed by Secretary Sir E. Grey to state that a list of British prisoners of war, which has been communicated to the Commander in Chief, Cape, by the German authorities of the Protectorate in question, only contains the names of the following persons out of your list:-

The Reverend and Mrs. J.H. Briggs and
The Reverend T.B.R. Westgate.

The list also contains the names of Mabel Puckham, William Green and Florence Evelyn. These names do not appear on the list furnished by the Universities Mission and they may therefore be those of members of the Church Missionary Society.

I do not know how far you are acquainted with the situation in regard to the release of the missionaries mentioned in your letter of the 15th inst. I have, however, to advise you that the release of the missionaries mentioned in your letter of the 17th inst. is being considered.

Should it be possible to arrange for the release of those missionaries who fall within the categories mentioned in your letter of the 15th inst. all the missionaries mentioned in your letter of the 17th inst. will be permitted to return to their own countries. It is, however, to be arranged subject to their own desires in the matter.

We should be glad to know whether you draw any distinction between "Prisoners of War" and other of our missionaries who may be "interned", or whether it is at all likely that these three missionaries are the only ones "interned", and that the others are permitted to
