"Your enquiry on behalf of Convention of Associations re importation of identured labour. Stop. To what countries besides China and Japan have you addressed enquiry. Stop. Have you received any replies and if so have you communicated them to the Convention. Stop. Please suspend all action in the matter as Foreign Office and Colonial Office are considering it in consultation".

views of the Convention of Associations expressed in February, was unfavourable to the importation of contract labour. partly because it was convinced that the importation would not serve the true interests of the Colony, and partly because it knows of no suitable sorts.

It may be added that following on the Convention's discussions on labour problems last vear, the Chief Native Commissioner was instructed to hold informal enquiries in regard to certain labour matters, and it appears from a recent telegram that investigation has not yet been completed. Also a further Commission was appointed on the 12th January to examine and report upon the needs of the Colony in respect of African labour outside the native reserves.

It is also clear that there is some opinion locally that the shortage of labour is exaggerated and that good employers have not much difficulty in getting men, and this view is expressed as a private opinion by the Deputy Trade Commissioner in his letter of the 15th December in this file.

I have the honour to acknowledge receipt of your despatch 1960/26 of the 15th December last, on the subject of the importation of labour from outside sources into Kenya Colony.

as it appears improbable that the Japanese Government would welcome enquiry as to the prospect of obtaining indentured labour from this country, in view of the implication of a low type of labour attaching to that term. I have, with the approval of His Majesty's Ambassador, refrained from submitting to the Japanese Authorities the questionnaire enclosed with your despatch. While agreeing with the opinion which you express, namely that the political disabilities of an importation of Asiatic - or at any rate Japanese - labour would more than negative any possible advantage of such importation. I may etate for your information that the policy of the Japanese Government is directed towards encouraging the emigration

of families and their settlement as peacent proprieters. At the present time plans are being prepared to send whole families to Brazil, where extensive tracts of land have been offered to, or sequired by, Japanese interests. The object in view is, by this means, to assist in relieving the pressure felt in Japan from the increase in population. The proposals made by the Convention of Associations would, however, not be in accordance with this policy, since they contemplate engaging labourers for a term of years only, on the expiration of which repatriation would presumably be effected.

From what is known of the activities of Japanese emigrants to imerica, for instance, they appear usually to work as labourers only long enough to sequire sufficient means to embark upon a business of their own, as market gardeners, shop keepers, etc., and they show a tendency to gravitate from the country to the cities.

- 3. It is clear that the employment of Chinese labour in Kenya Colony raises questions of very considerable political importance, and Sir Austen Chamberlain would be glad to be furnished with any observations which Mr. Secretary Amery may care to offer on the subject in general.

The Department of Overseas Trade transmit herewith to the Foreign Office copy of a despatch and of its enclosures from the Commercial Counsellor at Pexing, relative to a request from the Secretary of The Convention of Associations of Kenya Colony for information regarding the conditions under which the Chinese Government would permit Chinese labourers to emigrate to East Africa.

- 2. The employment of Asiatic labour in Kenya Colony involves important political considerations and the enquiry would appear to concern the Foreign Office and Colonial Office, rather than the Department of Overseas Trade.
- 3. The original of ir. Fox's reply to the Deputy Trade Commissioner, Nairobi, is also enclosed herewith. If the Foreign Office agree to its tenor it is requested that they will forward it to the Colonial Office for transmission to Mr. Kemp by that Department, should the Colonial Office see no objection.

I have the honour to forward, under flying seal, a letter which I have addressed to the Deputy Trade Commissioner at Mairobi in reply to a communication from the Secretary of The Convention of Associations of Kenya Colony, copy of which I have the honour to enclose, regarding the terms on which the Chinese Government would allow Chinese labourers to emigrate to Bast Africa.

I trust the non-commital reply I have made to the Deputy Trade Commissioner may meet with your approval. In view of present disturbed conditions in China and the delicate negotiations which His Majesty's Government are now conducting with the Southern Sovernment the moment is. I venture to think, hardly an opportune one for approaching that government who would be the authority principally interested on a matter of this kind. You may, however, does it advisable to authorise the Deputy Trade Commissioner to inform the Secretary of the Convention that when normal conditions are restored in this country an endeavour will be made to obtain the information which he has asked for.

I have the honour to acknowledge receipt of your despatch No.1959/26 of December 15th last on the subject of the labour supply in Kenya Colony.

The question asked by the Secretary of The Convention of Associations in paragraph 3 of his letter would necessitate a reference to the Chinese Government which I am not in a position to make unless especially authorized to do so by His Majesty's Principal Secretary of State of Foreign Affairs to whom I am forwarding a copy of this correspondence.

As regards the questionnaire, I have not the information in my possession which would enable me to make an adequate reply. I should have to refer the questionnaire to His Majesty's Consuls at ports in China, such as Amoy and Swatow, where there is emigration to the Straits Settlements and other British colonies, and here again I am unable to make a request which would probably involve consultation with the local Chinese authorities without instructions from H.M.Government.

The employment of Chinese labour in British colonies is regulated by the Convention between Great Britain and China signed at London on May 13th 1904 and a perusal of the terms of this agreement would, I think, give the Convention a good idea of the conditions under which Chinese labour is employed in certain

I have the honour to inform you that the question of importing labour from outside sources into Kenya Colony has been raised in The Convention of Associations, which is a body to which are affiliated almost all the District Farmers' Associations. The Convention has appointed a Committee to examine the question and that Committee is anxious to obtain information from various sources of labour supply.

The Secretary of The Convention has now asked me if I would pass on to you the enclosed papers with the request that you would be so good as to complete the questionnaire as far as is possible in relation to your area.

It may be of assistance to you if I state my private opinion that allegations of a labour shortage in this Colony have been considerably overstated and that the political disabilities of an importation of Asiatic labour would more than negative any possible advantage of such importation.

At the same time, I should be grateful if you would kindly let me have as complete a reply as you consider necessary for the purposes of the Convention, together, if you consider it advisable, with a confidential note for my own guidance in the matter.
