It is no doubt true that if this land is used for pastoral purposes we need not trouble about the effect on the labour market. But whether its pastoral use will justify anyone in boring for water is a different matter.

On both points (1) that the tenant must not be led to expect claim on the agricultural labour supply of the country and (2) that his expenditure will not make it possible for him to cultivate high value crops, I think that the offer of leases should definitely be on a non-agricultural basis.

This would lead us with the Game Reserve point, and I think it is essential that we should be able to assure the S.P.F.E. from the start that a satisfactory substituted

With reference to your Confidential despatch of 16th July regarding the proposed development of the waterless land lying between Sultan Hamud and Makindu to the south of the Uganda Railway, I have the honour to inform you that I have considered with my Executive Council the general problem to which you referred in the second paragraph of your despatch.

I am advised that the land in question is likely to be taken up as grazing land rather than agricultural land and that the boring operations are unlikely to result in finding water in sufficient quantities for agricultural development. Stock raising makes no serious demand upon the labour market and obtains what labour it requires from those pastoral tribes which contribute very little to the labour supply for any other purpose.

The Acting Chief Native Commissioner was therefore satisfied that the alienation of these lands would not appreciably affect the labour problems of the Colony.

set aside in anticipation for that  
which, under this scheme, would be

future discussion, but as soon as that  
became known that the area is being  
thrown open for development it would  
be supposed that the Govt. for its own sake  
the fauna of the Reserve is of course the subject

Sir,

I have the honour to acknowledge the receipt of your Confidential despatch No. 219 of the 28th of November and to confirm my telegram of the 28th of January, in which I informed you that I approved of the initiation of the scheme of development of the waterless land between Sultan Hamud and Lakindu on the definite understanding that land in that area will be offered for grazing purposes only.

2. It appeared to me to be undesirable that anyone should be led to take up this land in the expectation that agricultural labour will be available in numbers sufficient for the cultivation of the high-value crops, which alone could justify the capital cost of extensive water boring, or that they should be led to believe that boring operations, however extensive, would produce a water-supply adequate for agricultural purposes. If the offer of land is expressly for grazing purposes, the Government will be free from any blame for misleading its licensees and will avoid a drain on the available supply of labour for agricultural operations the financial success of which must be open to serious doubt.

3. In my telegram I enquired as to the locality in which land could be set aside in substitution for that which, under this scheme, must be withdrawn from the Southern Game Reserve. Mr. Denham, in his despatch of the 21st of May, left the point over for future discussion, but as soon as it becomes known that the area is being thrown open for development it must be supposed that the Society for the <sup>protection</sup> Prevention of the Fauna of the Empire will at once raise the question of the substituted area.
