With reference to your despatch Kenya No. 44 of the 16th January, 1926, I have the honour to transmit herewith a Form of Particulars required for the computation of pension payable to Subadar Major Sheo Nand, First Grade Chief Warder, Prisons Department, who is retiring from the service on completion of the maximum period of engagement under the Prisons Ordinance.


