Sir,

With reference to Mr Jarvis's despatch No. 164 of the 1st May, 1925, on the subject of the granting of facilities for officers, their wives and families when proceeding on local leave, I have the honour to submit a draft circular showing the new conditions I propose to introduce into Uganda, subject to your approval.

2. Medical opinion is emphatic as to the importance of local leave, and I consider that it is highly advisable that officers should secure the greatest possible benefit by visiting either the Highlands or the Coast of Kenya which alone provide the necessary change of climate.

3. In view of the geographical position of the Protectorate such a journey entails considerable expense, and there are but few officials who find themselves able to meet the cost incurred.

4. I consider that the question of health is of primary importance, in the interests of efficiency, and, while fully alive to the necessity of observing economy, I feel justified

LOCAL LEAVE

Granted Subject to the Exigencies of the Service.

The Secretary of State for the Colonies has approved that, as an alternative to the present arrangement by which an official is entitled to 14 days' local leave during each year of resident service, a cumulative grant of 28 days' leave should be allowed, if preferred, once during each tour of service. No Officer shall be allowed to take 28 days local leave until he has completed 12 months residential service.

2. This concession is granted for the specific purpose of visiting a healthy part of the Kenya Colony, to be counted from the day on which the officer leaves a Lake Port. Or in the case of officers proceeding to Kenya, by car, from the day after they cross the Protectorate boundary. No Officer shall have his travelling expenses while on local leave paid for more than once during a tour of service.

3. An Officer availing himself of this privilege will be provided with a free return ticket between Uganda and Nairobi, and in the case of a married official, for his wife and family and one servant. This concession may be extended to Mombasa on special sanction only. A baggage allowance of 160 lbs. in excess of that granted on a ticket will be sanctioned.

4. Officers going to Kenya or elsewhere by car, may draw an allowance equivalent to the cost to Government of the return fare to Nairobi, with the proviso that ordinary mileage allowance will be paid in the event of it working out at less than the return fare.

5. Officers from up-country Stations proceeding to Kenya will be granted transport allowance to the nearest Lake Port, or if using their own car will receive motor allowances to that Port, or to the Protectorate boundary.

6. Officers wishing to spend their leave in the vicinity of Mombasa, Fort Portal, Mbarara or Kigezi, will be granted free transport and leave by the normal van services, but if using their own car will be granted motor allowances with the proviso that these shall not exceed the cost to Government of a return ticket to Nairobi. This concession will not extend to any expenses incurred in connection with porters. Leave will in this case be counted from the day the officer passes his District boundary.

7. Travelling allowances will not be paid during local leave.
