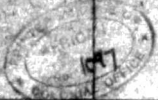

Telegram from the Governor of Kenya to the Secretary of State for the Colonies, dated 3rd December, 1924.

(Received Colonial Office 8.25 p.m. 3rd December, 1924).

341. 3rd December.

My despatch of 15th October, No. 241. Confidential. Estimates. Session of Legislative Council will take place on 16th December. Owing to the Royal visit it will not be convenient to hold meeting at a later date in December. I shall be glad if you will notify as soon as convenient before 16th December your decision on the estimates and on additional expenditure requested in my despatch No. 234. Confidential of 8th October. I am asking by separate telegram for £5,000 to be included for Publicity Office and in my despatch Confidential No. 276 of 28th November asked for additional 2872 for a new embossing machine. I shall be glad to be authorised to include these on the third reading of the estimates and to take the third reading at the forthcoming session. Extra revenue also to be added notably £10,000 Magadi Stamp royalties outstanding and due on signature of new lease(s) see correspondence ending your telegram of 25th November. Commissioner of Customs now estimates that considerable addition may be made to Customs revenue for next year. Estimates were prepared by Acting Commissioner and the figures for the year are sent to you to increase full details regarding which forms are attached. It is not now proposed to provide for any further additions to expenditure than those above referred to and balance will be brought forward as anticipated surplus.
