Sir,

I have the honour to inform you that with the concurrence of Executive Council, and on the recommendation of the Chief Native Commissioner, I have approved subject to your covering sanction the grant of 5 acres at Keremare in Embu district and 5 acres at Akerangondi in Meru district to the Italian Roman Catholic Mission.

2. The conditions of the grants are as follows:-

(1) A yearly Temporary Occupation Licence will be issued pending survey and thereafter a lease for 20 years will be granted.

(2) A rental annually of 25/-

3. The natives concerned have consented to these grants and the rents will be paid into the Natives Trust Fund.
