STATEMENT OF CASE

In answering the following questions the Board will implicitly assume that the statements contained therein are true and correct. These statements will be reduced to the signature documents. When possible, a statement by the medical officer will be obtained.

Incident: On January 10, 1921, while working at his residence, located at 1000 N. 1st Street, he was struck in the left eye by a piece of iron which fell from a roof of a building. He was not wearing glasses at the time of injury. At the time of the accident he was wearing a leather cap.

Consequently the following facts bearing on the history of the disability presented as follows:

Board enquires: Has the injured person been seen since the time of the accident? If so, by whom?

Answer: Yes, he has been examined by Dr. J. W. D. on January 10, 1921, and again on January 11, 1921, by Dr. J. W. D. and Dr. J. W. D. He has been continuing to take care of himself and has been able to do all of his work about the house, generally, and able to go all places he wants to go.
