## GENERAL CONDITIONS.

- 1. The eres of land to be 5 sores with an optionover an additional 8 sores adjoining.

  (provided the 5 sores already granted
  are inadequate for the purpose for which
  they were granted) such option to be
  exercised within 5 years of the date of
  the grant at the market rate then gurrent.
- The Lease to be for a term of 99 years from the first day of the month following the Assue of the grant.
- The rest to be an the same rate as that of other stacking picts at Nakuru if and with Auch are motioned.
- 4. The pur was price to be pre-rate to the everage price realized of other stacking plots at Nakuru if and when suctioned, provided such assign is held within a aix months of the date of the grant.
- 5. In the event of the auction not being held within the premoribed period the rent and purchase price to be assessed in the usual manner. i.e. 1/5 of estimated value of plot to be the purchase price.

  6% of 4/5 of estimated value of the plot to be the rent.
- On payment of the purchase price the value of the Lendiani Plot which Government are committed to grant to Major Grogan is to be estimated and deducted.

- The fellowing are the covenants to be lumerted in the Lease
- and the Stanking of Timber and for no other purpose whatsoever.
  - 2. The Leases shall erect on the plot buildings and machinery suitable for the purpose for which the plot was granted and shall complete the same as a going concern within two years from the date of the Grant.
  - 8. Such buildings to be erected according to plans and specifications which must be approved in writing by the Commissioner of Lands or such other official as he may appoint for the purpose.
  - 4. The Lesses shell be responsible to: the proportionate cost of construction of the sidings and road of roads serving the Stacking Flots such cost to be leviable on the completion of each sidings and roads.
  - The Lesses shall drain his plot to the satisfaction of the Government and shall connect such drainage with any main drainage system of the Township of Nakuru as me 5 hereafthr he constructed.
  - t. The Lessee shall keep his plot in a clean and sanitary condition to the satisfaction of Government.
  - 7. The plot shall set at any time during the term be used as a place of residence by any person or persons whatsoever with the exception of caretakers in the amploy of the Lesses.
- 8. The Lessee shell not assign sublet or otherwise part with the passession of the land lessed or any part thereof without the previous consent of the Governor in writing.
