The Committee considered the medical report on Kenya for 1919.

Professor Simpson called attention to the high proportion of typhoid cases in Nairobi. He called attention to the ~~report~~ to the bad condition of the water supply and said nothing could be expected until the whole waterworks was protected. The Committee recommended that enquiry be made as to what has been done in this direction. Mr. Foxkynne pointed out that the ... responsible and that they were still considering what steps to take. Sir J. Kingston Fowler drew attention to the reported condition of the aerated water manufactured locally. Professor Simpson also drew attention to the reported pollution of streams and suggested that a special report on this situation should be called for, showing the exact condition of affairs and the remedy proposed.

He also referred to the reported ... condition of the Levanjee market and the Committee agreed that enquiry should be made as to this.

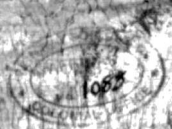
