Referring to your letter No. 3549/1921 of the

& Co., on the subject of their claim of inferior flax
seed supplied by the Flax Control Board, I have the

I enclose copies of two letters which passed
 between the Colonial Office and the War Office Contract
 Department, in August last on the subject of the ships
 East Africa of flax seed. The quality in which you
 interested, was shipped by the s.s. "Stateamer" from Li
 on the 7th November, in 135 x 3½ bushel bags, and we
 paid the claim of the Flax Supplies Committee, Belfast
 for these 135 bags at the rate of £10 per bag.

Shipment was made along with 1027 bags sent
 Government account, and the committee's claim in respect
 bagging, marking and transport to Liverpool, of the whole
 consignment, amounted to £386.19. 4.

I enclose a statement of claim amounting to
 £1,539.16. 8 being the cost of these 135 bags, and we
 be glad to receive your cheque for the amount at an early
 date.

To distinguish these 135 bags from the rest of
 consignment, we arranged for them to be marked with
 W, and we have informed the Government of the M.A.P. by
 telegram that the bags so marked are for you.
