Your telegram 15th December maximum price of maize it is represented that there is still a fine maximum price of £3.5.0 per quarter for East African maize sold United Kingdom whereas for mixed American maize maximum price is £3.5.0 with result that business has been done at rate of over 14%. It is alleged that owing to high exchange East African maize cannot be sold at profit at £3.5.0 per quarter. Had you arranged for control price of East African maize to be removed in order that it can compete in open market. Submit that high exchange justifies special case of East African exports.
