The enclosed memorandum
shows the arrangements
which, in my opinion,
will best secure this
object. You will observe that
I consider that, with
certain exceptions, all
officers should be required
to travel by the all-sea
route via Ceylon by the
steamers of the Union
Castle and British India
lines, and that the
passage ~~of~~ of the officers
himself should always
be paid for by the Govt.,
there

there being no necessity to
inform the officer of the
amount actually paid
for his passage, since
the cost of his passage
will be held to be the
scheduled cost for the
purpose of calculating
any further payments
for which he may be
eligible. I may observe
in this connection that
it is not the case, as
suggested in the despatch under
aid, that a ^{conf.} rebate is
allowed by the Shipping Companies.
