I have the honour to refer to paragraph 2 of Mr. Churchill's Confidential despatch of the 6th January last regarding the possibility of reducing the establishment of the Provincial Administration.

2. In Sir Edward Northey's Confidential despatch No.190 of 8th August, 1922, there was enclosed a Schedule showing a proposed total strength of officers for the Provincial Administration of 126 as against the existing establishment of 150. That total of 126 included two Senior Grade Posts, viz: the Assistant Colonial Secretary and Deputy Chief Native Commissioner, and two II grade posts on the Governor's Staff, viz: the Private Secretary and Aide-de-Camp. As these four posts are not considered to be interchangeable with the general Administrative Staff, I propose to omit reference to them in dealing with the establishment of the Provincial Administration. The total of 126 thereby is reduced to 122.

3. In pursuance of the policy of reducing expenditure as far as possible, the Senior Commissioners were invited to a conference with the Chief Native Commissioner and with the Economic and Finance Committee to ascertain what further reductions of staff in
