making a total area of 25476 acres more or less the subject of this Grant to H.W.H. for the term of nine hundred and ninety nine years from the first day of January One thousand nine hundred and twenty. —— subject to the payment therefor for the said term the respective rents following payable in advance at the first day of January in every year and so in proportion for any less period than one year namely:-

- (a) From the 1st day of January One thousand nine hundred and twenty one until the 31st day of December One thousand nine hundred and forty five an annual rent of Rs.500/-;
- (b) From the First day of January One thousand nine hundred and forty six until the thirty first day of December One thousand nine hundred and seventy five an annual rent calculated at the rate of one per centum on the unimproved value of the land hereby granted in the year One thousand nine hundred and forty five.
- (c) From the First day of January One thousand nine hundred and seventy six until the thirty first day of December Two thousand and five an annual rent calculated at the rate of two per centum on the unimproved value of the land hereby granted in the year One thousand nine hundred and seventy five.
- (d) For every subsequent period of thirty years thereafter to expire on the thirty first day of December in every thirtieth year following until the expiration or sooner determination of the term hereby granted an annual rent calculated at the rate of three per centum on the unimproved value of the land hereby granted in the year preceding the first year of such a recurring period of thirty years.

This Grant is subject to the provisions and conditions contained in the Crown Lands Ordinance One thousand nine hundred and fifteen (excepting part eleven thereof) and the Registration of Titles Ordinance One thousand nine hundred and nineteen and also to the special conditions hereunder written:-

1. The Grantee shall pay the costs incidental to the survey of the land hereby granted amounting to Rs.4025 payable by ten

- The Governor of the said land divide or subdivide the same or part thereof or assign sublet or otherwise part with the possession of any such division or subdivision in any manner whatsoever without the previous written consent of the Governor-in-Council.
7. The Governor shall not without the previous written consent of the Governor-in-Council appoint or allow a Non-European to manage or otherwise occupy or be in control of the said land.
8. Provided always and it is expressly agreed by and between the parties hereto as follows:-
- (1) The Governor shall by instrument under his hand from time to time appoint two officials to act as Trustees and similarly may revoke such appointments and appoint new official trustees in their stead to superintend generally the due and proper management of the premises the subject of this Trust and generally to exercise control over expenditures and all transactions loans mortgages and other charges moneys and things of whatever nature incidental to the proper and efficient management of the premises.
- (2) The following officials, namely the Director of Agriculture and the District Commissioner Keriara or the officers of the said being executing the duties of such offices shall be the first Trustees with effect from the date hereof and shall be deemed to have been duly appointed under an instrument in that behalf on the signing hereof by the Governor.
9. It is agreed that no loan mortgage charge or other charge shall be levied on the premises or crops growing thereon or belonging to the Grantee or issued overdrafts at the rate of interest to such conditions as shall be approved by the Trustees in writing and whenever possible in any transaction of the nature aforesaid the Trustees shall be the parties for the purpose of signifying their assent.
