Re your letter dated 15th June 1920,
I enclose herewith for your convenience,
the General Manager of the Uganda
Railway has stated that Acting Allowance cannot be paid
to a junior officer while that officer is on
leave for a short period through illness.
The very definite nature of the statement
in your letter of the 15th June 1920, in the
above case has naturally caused a considerable
amount of concern among the officers concerned. I beg to
state that possibly the General Manager is not aware of the
nature of this ruling made by the Colonial Office and I
trust, therefore, that the matter will have your attention.
The statement in your letter is quite unqualified and the interpret-
ation naturally placed upon it by the officers is that when, by
reason of the absence of the officer who holds the substantive
appointment, a junior officer is holding that appointment for the
time being, he shall be entitled to the Acting Allowance.

Trusting to have a satisfactory reply on the matter in
the near future.
