My Lord Duke,

I have the honour to refer to my telegram No. 377, of the 10th instant respecting the appointments to the new Office of Registrar General, Public Trustee and Official Receiver.

2. The invaliding of Mr. Musgrave Thomas necessitated other temporary arrangements being at once made for carrying on the duties of Administrator General pending the appointment of a Registrar General. I have to request that, subject to the Estimates for 1924 being approved, Your Grace will take the earliest possible steps to fill the new post created. It is desirable that the Officer appointed should have had experience of trustee work and should be capable of carrying out the duties enumerated in Sir Charles Bowring's despatch No. 1265, of 13th August, 1923.

3. There are no suitable local applicants. Mr. S. H. Carnelly, Resident Magistrate, originally applied, but he withdrew his application on the reduction of the scale of salary to £700 to £800.

4. I take this opportunity of recommending Mr. B. Stone, Deputy Registrar, Supreme Court, for the


