In reply to your letter — I am directed by the Oversea Settlement Committee to inform you that it is not proposed to alienate any further Crown land in Kenya Colony for some years, and persons proposing to settle there should be prepared to purchase land in the open market from existing holders.

At the present time the price of land in Kenya is not high and not infrequently farms may be bought on very favourable terms. On the whole the native labour supply is good but from time to time shortages of labour are experienced. Rent however depends on the personality of the employer.

For those with no African farming experience it is advised that they should possess a capital of at least £35,000 on arrival a larger sum being desirable. Settlers with local experience are advised that a minimum capital of £15,000 in addition to all money and incidental expenses is about correct. You without this amount of capital should not proceed to Kenya unless they have obtained definite



As elsewhere Kenya has suffered from an extreme depression, but it would appear that matters are slowly righting themselves and the outlook is much more promising than it has been for several years.

Finally settlers going to Kenya are reminded that some knowledge of making ability to plan and erect simple buildings to effect small repairs etc. will be found invaluable.
