With reference to your letter of the 14th of August last, relating to the proposed establishment of a direct exchange of parcels between France and Kenya and Uganda, I am directed by the Postmaster General to state that, from an enquiry which has been received from the Postmaster General of the Tanganyika Territory, it appears that the question of initiating negotiations with the French Administration for the purpose of establishing direct parcel mails between France and the Tanganyika Territory is under consideration. The service, if established, would be used not only for parcels from Tanganyika for the Continent of Europe (which at present pass through this Country) but also for parcels for this Country itself in place of the existing service <sup>by</sup> ~~under~~ which parcel mails are despatched from Tanganyika to Aden and are conveyed thence, as a rule, by Peninsular and Oriental Packet.

The Post Office of Tanganyika suggests that the French service might be used for Parcel Mails from this Country for Tanganyika also; but there is no intention at present <sup>of setting</sup> ~~of setting~~ up such a service, as it is impracticable to forgo the important financial advantage for this Department of sending the Parcel Mails for Tanganyika by the contract packets of the Peninsular and Oriental Steam Navigation Company.

Although diversion to the French service of parcels from Tanganyika will involve some small financial loss to the British Post Office, it is probable that the

existing arrangements for the conveyance of parcel mails from Tanganyika compare very unfavourably with those in force before the war; and the Postmaster General will be glad to learn whether in all the circumstances the Secretary of State for the Colonies concurs in the suggestion of the Tanganyika Post Office to negotiate an Agreement with France and whether he agrees that the Instrument might be similar to that which has been proposed for the service between France and Kenya and Uganda.
