Memorandum

Re. Issue of Certificates to soldiers
mentioned in the Field during the
War 1914-1918.

With reference to your No. S.R0959/* dated 9/2/20, I am
enclosing herewith extracts in triplicate from the London
Gazette forwarded by you.

I have added also extracts from the Supplement to the
London Gazette dated 5/6/18 (Number of Gazette is not known
by me as I have only got an advance copy of the Supplement).
It will be noted that my lists contain a few Officers with
British Units (such as Major. Kemphorne, R.E., Major Hopkins
R.A. etc.) Those included are known B.E.A. Residents who
served with the K.A.R. I take it that the reference in
para 2 of the Secretary of State for the Colonies' despatch
D.1263 refers to men of British Units who served for a period
with the K.A.R. and subsequently returned to their Home Units.

As regards distribution of certificates, may I suggest
that this should not be done by the Colonial Office direct,
but that the certificates should be sent out here for dis-
tribution by this office. The addressees that I have given are
the latest that I have got, but as nobody once discharged ever
notifies a change of address to me, some of them are very out
of date. I am at present noting free gratuity claims, which are
sent in to me for verification by the Paymaster, claims for
passages etc., the most recent address of every one who has
served with a view to facilitate the distribution of medals etc.
