No. 171. April 1st. By telegram 1st April 170 please arrange for selection and despatch as early as possible following expert staff required required for purpose of income tax. One Superintendent possessing necessary qualifications to organise collection of tax and to advise on any flaws in legislation. He should possess knowledge of machinery and forms in use in United Kingdom and elsewhere. Also two fully qualified Assistant. Indian experience would be very valuable. Two have provided £18,000 in (?) draft estimates for salaries of above three officers and have also made due provision for clerical staff. Am unaware whether provision made is adequate and suggest that detailed arrangements and possible revision of estimate be left to Superintendent to advise on when he arrives.
