My Lord,

I have the honour to report that I have approved the amendment of Rule 7 (a) of the Reformatory Schools Ordinance, 1910, by the addition of a heading empowering the Superintendent of the Reformatory to administer corporal punishment not exceeding 6 strokes with a light cane to inmates of the Reformatory.

2. The grant of additional powers of punishment was unanimously recommended by the Committee of Visitors and was supported by the Acting Chief Justice.

Previously canings up to 12 strokes could only be inflicted by a Committee of Visitors and for serious breaches of discipline only, and it is the opinion of my Executive Council, in which I concur, that discretionary powers, such as vest in schoolmasters at home, can safely be entrusted to the Superintendent thus enabling him to deal with minor offences for which a light caning appears to be the most suitable punishment.


3. A register will be kept of all corporal punishment inflicted under the Rule and a monthly return will be furnished to the Chairman of the Committee of Visitors.
